



Alpha Trader Firm – Tesla Model Y Promotion

Official Rules & Disclosures

1. Promotion Overview

Alpha Trader Firm is offering participants the opportunity to win one (1) Tesla Model Y (the “Prize”) as part of a limited-time promotional campaign. Participants who qualify during the Promotion Period will receive entries (“Tokens”) into a random drawing. One eligible participant will be selected as the winner.

Optional Cash Alternative: If the selected winner does not wish to receive the Tesla Model Y, they may instead choose a cash prize valued at \$40,000 USD, issued in lieu of the vehicle.

2. Promotion Period

Start Date: January 15, 2026

End Date: March 31, 2026

Winner Announcement: April 15, 2026

Alpha Trader Firm’s internal systems are the official timekeeper.

3. Eligibility

This promotion is open only to legal residents of the United States and individuals eighteen (18) years of age or older at time of entry.

The following are not eligible to participate:

- Employees, contractors, officers, or directors of Alpha Trader Firm
- Immediate family members of the above
- Any individual prohibited by applicable law

4. How to Enter

A. Entry With Qualifying Purchase (Automatic Entry)

Participants may enter by purchasing any eligible Alpha Trader Firm challenge or Instant Funding account during the Promotion Period and applying promo code **NEWCAR** at checkout. The discount is applied automatically and entry is issued upon successful purchase confirmation. All qualifying purchases receive entries.

B. Free Alternative Method of Entry (AMOE)
